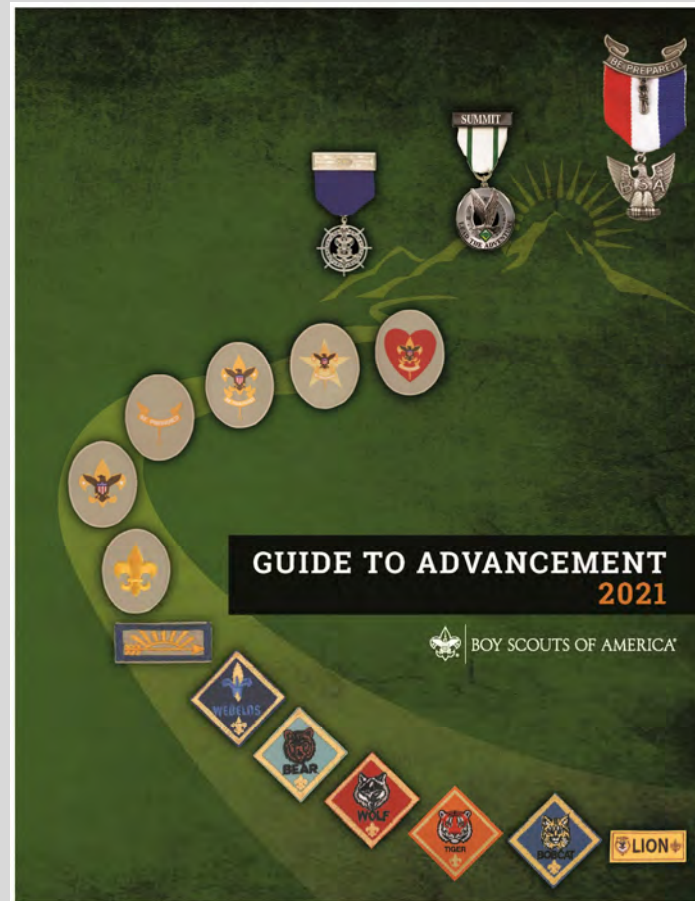

What's a Board of Review?

After a Scout has completed the requirements for any rank, the Scout appears before a board of review.

Its purpose is to determine the quality of the Scout's experience and decide whether he or she has fulfilled the requirements for the rank.

Board of Review No-No's

8.0.0.3

- ❖ Unit leaders and assistants cannot serve on a board for a Scout in their unit.
- ❖ A parent or guardian cannot serve on a board for their son or daughter.
- ❖ The candidate, parent, or guardian cannot select members of the board.



How are Eagle Scout Boards of Review the same as those for Tenderfoot thru Life Rank?



- ❖ Both shall have no fewer than three and no more than six members.
- ❖ All Board members must be 21 years of age.

All members should be registered Committee members

*exceptions may be made for small troops

Members need not be registered adults.

At least one District or Council representative must serve on the board.

Typically lasts 15 – 30 minutes.



Typically lasts 30 – 45 minutes.

If scout does not pass the Board, second Board can be held in the future.

Only one Board possible*

*We'll be discussing Appeals and Boards Under Disputed Circumstances.

Can take place as soon as the Scout has completed the requirements.

Must not take place until Council has “verified” the Eagle Scout Rank Application.

Could take place at summer camp.



Usually occurs in a more formal location

- ❖ There are some who believe the board of review is like a job interview. Nothing could be further from the truth.
- ❖ The Scout has already “earned the position” of Eagle Scout by completing the requirements. They are not interviewing for the position.

What to expect for your Eagle Scout Board of Review

- ❖ Expecting the Scout to appear in “business attire,” grilling them on their qualifications, asking inappropriate questions intended to cause stress and anxiety may all seem justified as making the Scout better prepared for experience in the “real world.” However...

What to expect for your Eagle Scout Board of Review

- ✦ ...the Scout is already in the “real world” of Scouting. The board of review is not about preparing the Scout for something but rather about celebrating their accomplishments.

What to expect for your Eagle Scout Board of Review

- ❖ Other youth leaders and adults who previously reviewed the Scout determined that the requirements were met when they signed off on the requirement, or merit badge, etc. It is not up to the board to decide whether the standards used by those leaders were or were not sufficient.

What to expect for your Eagle Scout Board of Review

- ♣ By the time Scouts have reached the Eagle Scout Board of Review, they have already demonstrated their knowledge and skills, many times over. This candidate is—for all intents and purposes—an Eagle Scout when arriving at the board of review.

What to expect for your Eagle Scout Board of Review

- ❖ Only in the most egregious cases where it was clear that the Scout could not possibly have properly completed a requirement would the board be warranted in determining that the Scout should not be advanced.

Board of Review Decisions

8.0.1.4-8.0.1.5

- ♣ Unanimous approval is required to advance.
- ♣ If no unanimous approval:
 - Do not disclose specifics to Scout.
 - Only discuss areas requiring improvement.
 - The board of review may be adjourned and reconvened at a later date.



Appealing a Decision

[other than the Eagle Rank]

8.0.4.0

- ✦ Tenderfoot, Second Class, First Class, and Eagle Palms are not appealable.
- ✦ Only Star and Life rank can be appealed to the local Council.
- ✦ The scout or the scout's parent or guardian notifies the local council.

Appealing an Eagle Rank Decision

8.0.3.0

- ❖ If the board of review does not approve candidate, then the Scout may appeal to the Local Council.
- ❖ If the Local Council does not approve the candidate, the Scout may then appeal to the National Council.

Eagle Scout Board of Review After 18th Birthday

8.0.3.1

- ❖ May occur, without special approval, up to 24 months after a Scout's 18th birthday [2021 GTA]
- ❖ Beyond 24 months, the candidate, the candidate's parent or guardian, the unit leader, or a unit committee member must submit a Belated Rank Application.

Boards of review for any rank are meant to be face-to-face, personal experiences. From time to time, however, due to communicable disease, or as Scouts go off to college or the military, or live in very remote locations, for example, it may be difficult to hold in-person boards of review. In those rare situations where it is unreasonable to expect a Scout to travel long distances, or to wait several months, it is permissible to use videoconferencing. [GTA, 8.0.1.6]

If such boards of review are held, however, they must be conducted according to the following requirements. (fine print intentional)

1. The local council must grant permission to hold a videoconference board of review for the Eagle Scout rank. Videoconference boards of review may be held for other ranks without local council approval, but they still must comply with the following requirements.
2. All equipment, including the cameras, lighting, microphones, software, and Internet connection, should be tested ahead of time to provide the best audiovisual experience possible.
3. All members of the board of review must be visible to the Scout, and any observers with the Scout must be visible to the members of the board of review. No one within hearing range on either side shall be off camera. It is important to consider your technical capabilities when planning how many board of review members to involve. Observers should be minimized for any board of review, and this applies especially to videoconference reviews. Their presence can change the discussion dynamics.
4. For Scouts under the age of 18*, a parent or guardian of the Scout, or two registered BSA adult Scouters who are familiar with these requirements for videoconference boards of review, must be directly present with the Scout at the beginning of the conference. The Scouters may be from the nearest council, district, or unit. Their role is to verify that the Scout is in a safe environment and that the board of review appears to be in compliance with these requirements. Once all the members of the board of review are present on their end of the call and introductions are completed, and the review is about to begin, those with the Scout on his end must leave the room or move out of hearing distance unless they have specifically been approved to remain as observers. See topic 8.0.1.0, "Conducting the Board of Review," for more information.
5. Once the review process has been concluded, if the Scout is under age 18*, his parent or guardian, or two Scouters must rejoin the Scout. Their purpose is to be available to answer any questions that may arise, to join in the celebration of the Scout's accomplishment, or to be party to any instructions or arrangements regarding the appeals process or the reconvening of an incomplete review. Once this is done, the board members end the call and sign off.

6. Videoconference boards of review must not be recorded.
