Camping Department Refund Policy

Preparing for camp requires our council to make certain advanced commitments and purchases including food, program supplies, equipment, repairs and maintenance and to employ staff.

Here is the refund policy for the programs below:

RESIDENT CAMPS/PROGRAMS

Includes Camp Parsons, Camp Pigott and Camp Edward summer resident camps, High Adventure Camps, National Youth Leadership Training, Powder Horn and Wood Badge.

Per person deposit required for resident camps/programs is nonrefundable.

30 days or more prior to your session, up to 50% refund is possible when participants are involved in an accident, serious illness, death in the immediate family, moves out of the area or leaves Scouting.

Refunds are not available due to conflicts with other activities such as family vacation, team sports, school activities and the like.

If the Council cancels camp sessions, we will work to move reservations to 2022 summer camp or issue a full refund if that is not possible.

The Council cannot refund or reallocate Camp Cards or Camperships.

Resident Camp Refund Requests

All refunds must be made in writing to campingdept@seattlebsa.org no more than 10 business days after the unit's session. Include the reason for withdrawal, unit number, camp/session, and participants name. For questions, please call 206-725-0361.

SEASONAL CAMP PROGRAMS

Includes Family Camp and day-long events such as Merit Badge Days, 2021 Winter Camp, Shooting Sports Day, and Camp Halloween.

Fees for seasonal camp programs are non-refundable but are transferrable to another day-long camp within a year of the event.

SUMMER DAY CAMP

Includes summer district day camp programs

Refunds may be available when participants are involved in accident, serious illness, death in the family, moves out of the area or other extenuating circumstances

Refunds are not available due to conflicts with other activities such as family vacations, team sports, school activities and the like.

The Council cannot refund or reallocate Camp Cards or Camperships

Summer Day Camp Refund Requests

All refund requests must be made in writing to cmcneal@seattlebsa.org no more than 10 business days after the day camp session. Include the reason for withdrawal, pack number, camp/session, and participant's name.

Camp Rentals

A group will be eligible for a 100% refund or transfer if the registration is withdrawn 30 days or more before the event start date, or has withdrawn due to health reasons, or the event is cancelled by the Chief Seattle Council.

If registration is withdrawn two weeks prior to the event for reasons other than health, 25% of fees paid will be non-refundable and 75% will be eligible for refund or transfer.

Registrations withdrawn within two weeks of the event are not refundable, but may be transferrable. If during the event, the group withdraws for health reasons or the Chief Seattle Council cancels, a prorated refund or transfer will be applied.
